- Emotionally-Focused Mentoring is one example of what a cost-effective, stepped-care model of mental healthcare can look like. Because mental healthcare from licensed professionals is often difficult to access, we trained 10 lay therapists to focus on transdiagnostic intervention targets: the promotion of attachment security (creating more positive models of self/other) and emotion regulation skills in the context of close relationships.
- Project Aim: Based on the NIH Stage Model of Intervention Development and drawing from the literature on Emotionally-Focused Therapy, I developed and tested a 5-week psychotherapeutic intervention for at-risk insecurely attached first-year college students.
- Method: I conducted two studies, a feasibility & acceptability trial ( $N = 11$ ) and an open pilot trial ( $N = 82$ ) targeting transdiagnostic markers of psychosocial distress to enhance emotion regulation skills, attachment security, and mental health outcomes. Data were analyzed using Bayesian inference and multi-level modeling to track changes over time across five weeks.
- Results: Over the course of the program, participants reported decreases in attachment anxiety, attachment avoidance, depressive symptoms, and loneliness as well as increases in self-esteem. 100% of participants who completed the program ( $n = 55$ ) noted that the program increased their psychological wellbeing and enhanced their ability to have healthy relationships. All participants noted that they would recommend the program to a friend.

- Individuals who are most at-risk for developing Type II Diabetes are often treated alone, ignoring the family environment as a substantial predictor of their health. Using a family systems approach, this study helped couples make health behavior changes to prevent diabetes
- Aided in the creation of study protocol and intervention manual
- Served as a family consultant/couple therapist for multiple couples
- Worked with couples to increase motivation for change; evaluated and shaped maladaptive couple dynamics; assessed diet and physical activity habits; fostered improvements in health via SMART goals
